8-stage divider and oscillator Rev. 3 — 11 January 2022

1. General description

74AHC1G4208 is a 8-stage divider and oscillator. It consists of a chain of 8 flip-flops. Each flip-flop divides the frequency of the previous flip-flop by two, consequently the 74AHC1G4208 counts up to 2^8 = 256. The single inverting stage (X1 to X2) functions as a crystal oscillator or an input buffer for an external oscillator. When used as a buffer the output X2 should be left floating. The frequency of the output (Q) is the frequency applied to X1 divided by 256. The divider advances on the negative-going transition of X1.

The X1 input is overvoltage tolerant. This feature allows the use of this device as a voltage level translator in mixed voltage environments.













12. Crystal oscillator

12.1. Typical crystal oscillator circuit

A typical crystal oscillator schematic is shown in Fig. 8. R1 is the power limiting resistor, its value depends on the frequency and required stability against changes in V_{CC} or average I_{CC} . For starting and maintaining oscillation a minimum transconductance is necessary, so R1 should not be too large. A practical value for R1 is 2.2 k Ω .




Fig. 11. Package outline SOT353-1 (TSSOP5)
